

Transition Guidelines

Nationwide CareMatters® II enhancements

On September 14, 2026, Nationwide CareMatters II will receive several enhancements designed to provide greater client value and improve consistency across the CareMatters Suite of products.

CareMatters II Enhancements

- Waiver of Premium while long-term care benefits are being paid will now be included with all premium payment durations and will waive the full premium amount. ***This waiver will be added to all policies issued on or after January 1, 2026.***
- A pricing discount when a lump sum premium/1035 exchange is combined with a recurring premium option.
- Adding three new options; 20-pay premium duration, 8-year benefit period, and 3% compound for 20 years long-term care inflation protection.
- Discontinuing the availability of the Step-Up ROP option (except in NY), Pay to age 65 payment option, and 3% simple inflation protection option.

Important Dates and Information

September 14, 2026	Applications electing a discontinued option must be signed prior to September 14 th , 2026. The features added with the CareMatters II Enhancements can be illustrated and applied for beginning September 14 th , 2026.
October 2, 2026	Applications signed before September 14 th must be received at Nationwide no later than October 2 nd , 2026, to receive a discontinued CareMatters II feature.
November 30, 2026	Applications signed before September 14 th must be in force and funded by November 30 th , 2026, to receive a discontinued CareMatters II feature.

NOTE: The Step-up ROP, Pay to age 65, and 3% simple inflation protection options will be removed for all states on September 14, 2026, except for New York and California.
